Subject: Recruitment Rules for Non-Faculty posts for formal adoption at AIIMS Rishikesh-reg.

Sir,

I am to refer to AIIMS Bhopal letter No. 11/RR/ADMIN/AIIMS/BPL/1271 dated the 28<sup>th</sup> March, 2017 in regard to New Recruitment Rules 2015 for Non-Faculty posts for AIIMS Bhopal (copy enclosed).

2. As requested in the letter, a proposal to place the Recruitment Rules for Non-Faculty posts, pending approval of Institute Body (IB) for Recruitment Rules, 2015 along with the amendments as ratified by the Institute Body (IB) of AIIMS, Raipur and AIIMS, Jodhpur was put before the Hon'ble Minister of Health and FW, as the President of the Institute, for approval.

3. Keeping in view that Recruitment Rules with amendments have been ratified by all four AIIMS viz. AIIMS at Bhubaneswar, Raipur, Jodhpur, Patna and formal adoption of Recruitment Rules being the matter of grave importance and urgency as well as for smooth functioning of the hospital services in light of the recent delegation of powers to the Director of the Institute, the above said proposal was placed before the Hon'ble Minister of Health and FW, as the President of the Institute, for approval for AIIMS Rishikesh also.

3. In view of the above, I am to state that the above said proposal has been approved by the Hon'ble Minister of Health and FW, as the President of the Institute for AIIMS Rishikesh also. Henceforth, AIIMS Rishikesh is advised to initiate recruitment process for Non-Faculty posts immediately. Also, the said approved proposal may be placed before Institute Body (IB) for formal adoption of the Recruitment Rules.

Madam,

With reference to subject mentioned above and referred letters, following points are submitted:

(1) New Recruitment Rules 2015 for Non-Faculty Posts for AIIMS Bhopal:

Since, we are in receipt of the MOM chaired by the Additional Secretary (HFM) on 06.03.2017, vide letter No. MOHFW letter No.Z-28016/164/2015-SSH dt:17.03.2017 (copy enclosed at Annexure-1), in which, it was directed that proposal may be put up for seeking-Hon'ble Ministers approval for Non-Faculty posts of AIIMS Bhopal, pending approval of IB for Recruitment Rules-2015.

Therefore, in the light of above directions, you are requested to forward the said proposal to the Hon'ble Minister for Health and Family Welfare to approve the implementation of the New Recruitment Rules for Non-Faculty posts, pending approval of IB for Recruitment Rules-2015 along with the approval of the amendments in New Recruitment Rules which has already been ratified by the respective IB of AIIMS Raipur & Jodhpur.

(2) Power to appoint Senior Residents and Junior Residents by Director AIIMS Bhopal:

AIIMS Bhopal was advised by the Ministry (MOHFW) to place the proposal with regard to delegation of powers to the Director for appointment of Senior Residents & Tutor/Demonstrator etc., before the IB/GB vide letter No.Z-28016/24/2014-SSH (Pt) dt: 31.01.2017 (copy enclosed at Annexure-2).

However, in order to expedite and facilitate hospital services and Medical College functioning, the Ministry is again requested to re-consider the delegation of powers to the Director to appoint Senior Residents and Junior Residents under residency scheme as well as Tutor/Demonstrators and also for all non-faculty posts covered under A, B & C group employees including deputation posts.

(3) Construction of Bunkers for Linear Accelerator Machine and Deployment of Manpower for AERB permission for AIIMS Bhopal:

The construction work of bunker for procurement/installation and activation/use of the Linear Accelerator machine for the Department of Radiotherapy is complete. The vendor visited the site and the hardcopy of the map etc. have been shared and are to be handed over shortly.

With regard to AERB permission, it is submitted that faculty interviews for the department of Radiodiagnosis and Radiotherapy have been successfully completed.

MoHFW vide letter No A. 11013/01-2010-SSH dated 6<sup>th</sup> August 2013 have sanctioned one post of Medical Physicist (Group-A) and two posts of Radiotherapy Technicians (Group-B) under Hospital Support. The posts of Medical Physicist and Radiotherapy Technicians are under process of being advertised on contractual basis at AIIMS Bhopal and will be advertised shortly. Permission from MoHFW for advertising the said posts on Contractual basis, was sought vide this Office letter No. AIIMS/BPL/2017/483 dt: 25.01.2017 (copy enclosed at Annexure-3). It is again requested to grant approval for advertising the post of Medical Physicist (Group-A) on contractual basis for AIIMS Bhopal.


