
ORDER

Subject: Appointment to the post of Director, All India Institute of Medical Sciences, Bhubaneswar

The Appointments Committee of the Cabinet (ACC) vide their letter No. 5/6/2016-EO (SM.II) dated 22nd September, 2016 have approved the appointment of Dr. Gitanjali Batmanabane as Director, All India Institute of Medical Sciences, Bhubaneswar in the Pay Scale of Rs. 80000/- (fixed) + NPA of 25% of basic pay (Pay + NPA not exceeding Rs. 85000/-) on deputation basis, for a period of 5 years with effect from the date of assumption of charge of the post, or until she attains the age of 65 years or until further orders, whichever is earliest .

TERMS AND CONDITIONS OF APPOINTMENT OF DR. GITANJALI BATMANABANE AS DIRECTOR, AIIMS, BHUBANESWAR.

1. The Director shall be Chief Executive Officer of the Institute and shall exercise such powers and discharge such function as may be prescribed by the Society or Act or as may be prescribed by the Government or council of the New All India Institutes of Medical Sciences or by the Governing Body of the Institute.
2. The Director shall carry out such directions as may be issued to him from time to time by the Govt. of India for the efficient administration of the Institute.
3. The expenditure involved in the pay and allowances of the Director would be met from the Budget Provisions of the All India Institute of Medical Sciences, Bhubaneswar.
4. Scale of Pay
 - (i) Will be in the scale of pay of Rs.80,000/- (Fixed)+ Non Practicing Allowance subject to a maximum ceiling of Rs.85,000/-
 - (ii) With admissible allowances.
 - (iii) Residential Accommodation will be provided in the Institute's Campus on payment of standard rent under FR-45 or 10% of pay, whichever is less or alternate accommodation till availability of the designated quarters.
5. Tenure of Service
 - (i) The appointment is a tenure appointment for a period of five years from the date on which he enters upon this office or attains the age of 65 years or until further orders whichever is earlier.
 - (ii) The appointment as Director is permissible on Deputation/Lien only if Sanctioned by the parent State/Central Government Institution or an Autonomous Institute of National Importance or Institute of National Excellence declared so under an Act of Parliament.
 - (iii) The period of probation will be one year.
 - (iv) The Central Government, if it is of the opinion, that it is in the public interest to do so, will have the right to terminate the term of office of the Director at any time before the expiry of his term by giving a notice of not less than three months in writing or three months' salary and allowances in lieu thereof. The Director will also have the right to relinquish his office at any time before the expiry of the fixed term by giving to the Central Government a notice of not less than three months in writing.
